



CELTIC CONNECTION BREEDERS CLUB TERMS & CONDITIONS

By joining the Celtic Connection Breeders Club (CCBC), breeders agree to abide by the following Terms & Conditions and the Conscientious Breeder Agreement.

This club is exclusively for dog and cat breeders who feed and recommend Celtic Connection Holistic Pet Food. Emgee Trading bvba, the brand owner and producer of Celtic Connection Holistic Pet Food, reserves the right to terminate the membership of any breeders found to be in breach of these Terms & Conditions.

Terms & Conditions for inclusion and participation in the Celtic Connection Breeders Club (CCBC):

- I. All breeders must be aged 18 years or over, and own three or more breeding bitches or queens. Only one breeder or cattery/kennel may be registered per postal address.
- II. Breeders must be registered, and maintain that registration, with FCI, SRSB-KMSH, The Kennel Club UK, FIFe, TICA or WCF. Proof of registration will be requested and must be provided electronically prior to being admitted to the Club.
- III. Local council regulations and licence requirements must be adhered to.
- IV. Breeders participating in the CCBC scheme may not be a member of any other breeder scheme.
- V. Catteries and Kennels must display the Celtic Connection logo on their website and link social media accounts.
- VI. Breeders must not breed from a bitch or queen if the litter would be born before the bitch or queen is 12 months old, and after the queen is 5 years old or the bitch is 8 years old.
- VII. A minimum of 1 litter every 12 months is required to continue membership of the CBC, while no more than 4 litters can be produced over the lifetime of the bitch or queen.
- VIII. New litters must be registered with Emgee Trading bvba no later than 4 weeks from the date of birth.
- IX. Litters born before being accepted into the Celtic Connection Breeders Club cannot be registered retrospectively to claim kitten/puppy packs, and those that do will not be issued with kitten/puppy packs on that basis.
- X. All puppies and/or kittens must be exclusively weaned onto Celtic Connection Holistic Pet Foods.
- XI. Celtic Connection Holistic Pet Foods exclusively are to be recommended to new puppy or kitten owners.

- XII. One free new owner puppy or kitten pack will be provided for each new owner up to a maximum of 8 packs per quarter.
- XIII. New owner details shall be requested by the breeder no later than 7 days prior to collection of their new pet.
- XIV. All orders will be delivered directly to the registered address of the CCBC member.
- XV. Unless the breeder is an existing customer who has purchased 36kg of dog food or 15kg of cat food in the last 6 calendar months, a minimum direct order of 24kg of dog food or 20kg of cat food (excluding delivery) is required to activate an CCBC account. Proof of purchase and delivery will be requested prior to account activation.
- XVI. A minimum of 60kg for dog breeders and 40kg for cat breeders must be purchased directly in any 6 month period for your account to remain active. If your account becomes inactive you will lose your CCBC benefits.
- XVII. Celtic Connection Holistic Pet Foods are not for re-sale by the breeder, or for sale to a third party, unless agreed in writing by Emgee Trading bvba and subsequent to agreement of trade retailer terms and conditions.
- XVIII. Any discount or promotional codes may only be used by and for the addressed and registered CCBC member
- XIX. Emgee Trading bvba does not accept liability for any correspondence lost or damaged in the post.
- XX. Emgee Trading bvba reserve the right to change the CCBC offering and/or terms and conditions at their discretion and without prior notice.
